#### The challenge

In 2013, a newly appointed Chief IP Counsel within a large international manufacturing company with revenues over \$5 billion (USD) was reviewing their existing IP service relationships. The sought to achieve streamlining efficiencies, cost savings and translation quality improvements.

The manufacturer increased their average annual spend on translations and filings 74% in 2020 over 2014, seeking translations for EPs in nine different languages and PCT/National applications in six different languages, indicating a clear growth and expansion of their market due to increased opportunities.
