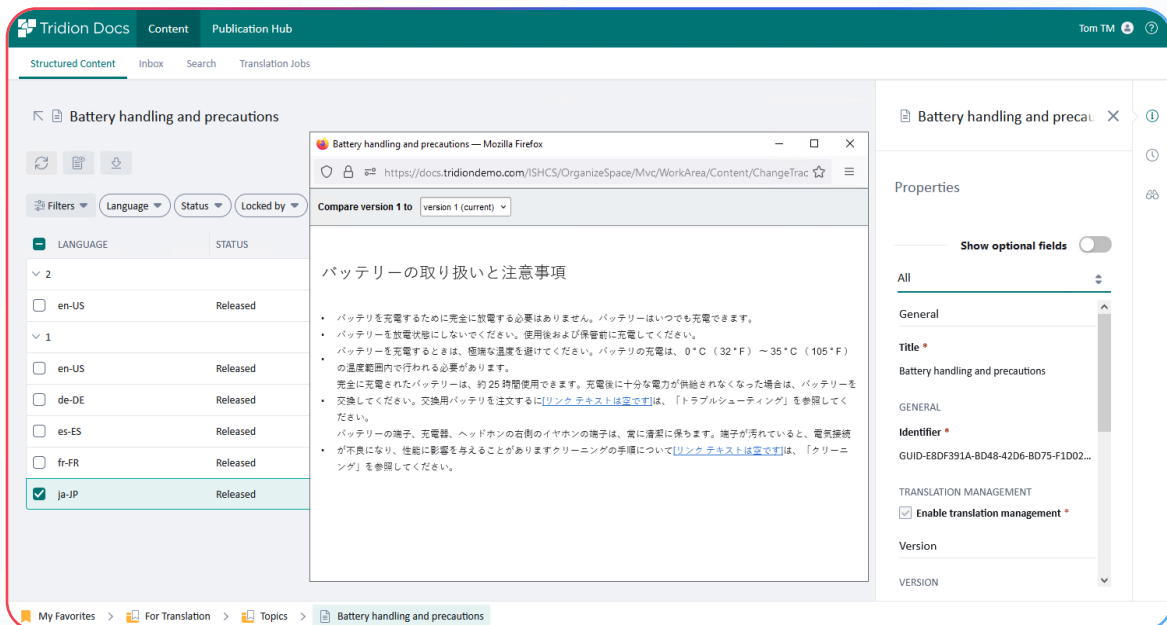
Tridion® Docs uses structured content and the DITA standard to make translations more accurate, cost-effective and faster.
